RESOLUTION NO. 166-2022(MSES), *First Reading*

A Resolution authorizing the Mayor to enter into an agreement with Gledhill Road Machinery Company for the purchase of a Salt-Spreader and Plow Package through the Ohio Department of Administrative Services Cooperative Purchasing Program; providing compensation therefor; and declaring the necessity that this legislation become immediately effective as an emergency measure.

WHEREAS, in order to meet operational needs, it is necessary to purchase a 14-Foot Stainless Steel Dump Body with Salt Spreader and Plow Package for the Department of Public Works; and

WHEREAS, Section 171.11 of the Cleveland Heights Codified Ordinances authorizes the purchase of machinery, materials, supplies, and other articles through the Ohio Department of Administrative Services Cooperative Purchasing Program ("ODAS Purchasing Program"), without obtaining competitive bids; and

WHEREAS, the Mayor has determined that the Salt Spreader and Plow Package can be purchased through the ODOT Purchasing Program at a better price that could be obtained by bidding.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Cleveland Heights, Ohio, that:

SECTION 1. The Mayor be, and he is hereby, authorized to enter into all necessary agreements for the purchase of the 14-Foot Stainless Steel Dump Body with Salt Spreader and Plow Package from Gledhill Road Machinery Company, through the Ohio Department of Administrative Services Cooperative Purchasing Program, at a price not exceed the sum of Ninety-eight Thousand Nine Hundred Eleven and 80/100 Dollars (\$98,911.80). All contracts hereunder shall be approved as to form by the Director of Law.

SECTION 2. Notice of the passage of this Resolution shall be given by publishing the title and abstract of its contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights.

SECTION 3. It is necessary that this Resolution become immediately effective as an emergency measure for the preservation of the public peace, health and safety of the inhabitants of the City of Cleveland Heights, such emergency being the need to meet vendor deadlines and equip the Department of Public Works with the referenced snow plow and salt spreader truck equipment as soon as possible. Wherefore, provided it receives the affirmative vote of five (5) or more of the members elected or appointed to this Council, this Resolution shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.
