Landmark Ordinance and Procedures

The Planning Department implemented fees for new nominations and Certificates of Appropriateness.

Landmark Properties

During the Collier-St. Angelo House (3417 Fairmount Blvd) designation, it was thought to be the only single-family home in Cleveland Heights designed by Janowitz, but Margaret has found 3 others.

The owners of the Hecker House (3585 Fairmount Blvd) are making progress on repairing rotted portions of their porch. They are using a carpenter referred to them by the Cleveland Restoration Society.

National Register of Historic Places

The Euclid Heights Historic District sign in the Euclid Heights Boulevard median at Coventry Road was struck by a car. Commissioners wondered if the motorist's insurance would cover the sign replacement.

Historic District signs for the Oakwood Drive District as well as Landmark signs for the Bradford Cinder Path will be ordered soon. The sign company sent over design proofs and a small change was requested.

Development Updates

The Noble Library Expansion will be reviewed by the Planning Commission on November 9th, 2022. It will then go through the Board of Zoning Appeals and the Architectural Board of Review.

The Taylor-Tudor project applied for Historic Tax Credits in September and will hear back in early 2023. The team is now working on concepts for the rest of the development phases (east side of Taylor Road).

The Park Synagogue development team presented at a recent City Council Planning & Development Committee meeting. They reached out regarding a National Register application.


