**-Howard Maier:** Highlights of the Administrative Services Committee proposal for two separate committees ([recording](#))

- **Proposed new Chapter 146 establishing a Cleveland Heights Transportation and Mobility Committee (TMC) with the purpose of making recommendations to the Mayor and Council on transportation plans for the City including assisting in the implementation of the City's Complete and Green Streets Policy Resolution No. 37-2018**
  - Name of the committee
  - Proposing a total of 7 members, from which 3 should represent cyclists, transient users, and people with disabilities. Balance of members will be at large. (TBD, appropriate number of members 7 or 9)
  - Four members will be appointed by Council and three members by the Mayor subject to Council approval
  - City Council designates a member as a non-voting liaison. No inclusion of a City Representative was proposed.
- **Chapter 150.01 establishing a Cleveland Heights Climate and Environmental Sustainability Committee with the purpose of advising the Mayor and Council on recommendations with regards to improving the environmental sustainability of City Programs and serving as an advocate for environmental justice and education in best practices for sustainable living and economic development. Discussion points:**

- Proposing a total of eight members, four appointed by Council, three by the Mayor with approval by majority of Council, and the City's Resilience and Sustainability Coordinator who shall serve as co-chair and non-voting member.

#### 4 Committee-initiated:

##### New Business

- Discuss the draft legislation proposing to change the name and makeup of the committee as delineated above
  - Proposal to review and possibly revise (if needed) the Complete and Green Streets policy. Note *“Director Zamft; he seemed open and supportive of this committee and adds a vision that this committee hasn’t seen from the administration prior to now. He did say that Public Works hasn’t fully bought into “Green Streets” but they are using the checklist. The policy may need updating”*

***The Cleveland Heights Department of Public Works has announced its Road Program for 2023.***

#### ***Resurfacing***

*Includes catch basin and manhole adjustments, spot curb replacement, and replacement of non-compliant ADA curb ramps.*

- *Coventry Road (Fairhill to Euclid Heights Blvd.)*
- *Lee Road (Mayfield to Superior)*
- *East Overlook (Coventry to Euclid Heights Blvd.) – Waterline and Road Resurfacing*
- *Warrensville Center Road – Cleveland Heights side (Mayfield to City South Corp Limit)*

#### ***2023 Construction Projects***

- *Installation of a new Traffic Signal at the Intersection of Fairmount, Coventry, and Scarborough (in conjunction with the Coventry Road Resurfacing Project)*
- *Lee Road Sanitary Sewer Overflow (SSO) Project (Euclid Heights Blvd from Lee Road to Cumberland – Control of SSOs at Lee & Euclid Heights Blvd.; Lee & Superior and Euclid Heights Blvd. and Cumberland)*
- *Monticello Boulevard Signalization Project (Belvoir to Mayfield)*

- *Cedar Glen Sanitary Sewer Replacement Project*
- *Compton Greenway Project (Installation of mini traffic circles at the intersections of Beachwood, Altamont, Desota, and Berkeley and a multi-use path connecting Compton)*
- *Cedar Lee ADA Ramp Project (Replacement of ADA Ramp and steps at the Cedar Lee Mini Park)*
- *Fairmount & Coventry SSO Control Project*
- Follow up on the suggestion that the City should hire an ADA compliance officer for this and other ADA provisions. **1/3/23 Minutes:** “*Councilor Larson spoke with the Law Director, and was informed that the law department is hiring new staff, and will consider this as they find new staff; want to find somebody with experience with this issue*”. **Update?**
