Action: Mr. Strauss made a motion to approve, seconded by Mr. Wong; the motion was unanimously approved.


3.11 ABR 2023-206: BAYVIEW FINANCIAL PROPERTY TRUST, 985 BRUNSWICK, request to alter roof.


