

RESOLUTION NO. 030-2024(PSH),
First Reading

A Resolution authorizing the Mayor to enter into an agreement with InVeris Training Solutions, Inc., to make the public improvement of upgrading and/or replacing the existing targeting system used to train Department of Public Safety, Division of Police personnel and Police Academy cadets; and declaring the necessity that this legislation be effective immediately as an emergency measure.

WHEREAS, the existing targeting system and associated equipment that InVeris Training Systems, Inc. installed in 1984 is approaching the end of its useful life;

WHEREAS, the services performed, and materials manufactured and provided, by InVeris Training Solutions, Inc., are uniquely compatible with the existing conditions of the improvement site and are familiar to the relevant personnel; and

WHEREAS, InVeris Training Solutions, Inc. has submitted a quote to upgrade the targeting system, attached hereto as Exhibit "A", the terms of which are reasonable and competitive; NOW, THEREFORE

BE IT RESOLVED by the Council of the City of Cleveland Heights, Ohio, that:

SECTION 1. Notwithstanding any provision of Codified Ordinances Chapter 171 to the contrary, the Mayor is hereby authorized to enter into an agreement with InVeris Training Services, Inc. to provide for the removal and disposal of the current targeting system as well as the provision and installation of a new targeting system, which shall include all associated hardware, software, and training necessary for its operation in an amount not to exceed One Hundred Thirty Thousand, One Hundred Fifty-Five Dollars (\$130,155.00). The repair agreement shall contain such other terms as recommended by the Mayor and Director of Law, and shall be approved as to form by the Director of Law.

SECTION 2. Notice of the passage of this Resolution shall be given by publishing the title and abstract of its contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights.

SECTION 3. It is necessary that this Resolution become immediately effective as an emergency measure necessary for the preservation of public peace, health, and safety of the inhabitants of the City of Cleveland Heights, such emergency being the need for the continued use of the targeting system used to train police personnel. Wherefore, provided it receives the affirmative vote of five (5) or more of the members elected or appointed to this Council, this Resolution shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.
