

RESOLUTION NO. 133-2025(COTW), *First Reading*

An Ordinance amending Ordinance No. 024-2025 for the purpose of reinstating the Regular Meeting of City Council previously scheduled for July 7, 2025; repealing the prior version of Ordinance No. 024-2025 in its entirety; and declaring the necessity that this legislation become immediately effective as an emergency measure.

WHEREAS, this Council passed Ordinance No. 024-2025 on February 18, 2025, for the purpose of canceling its Regular Meetings of July 7, 2025, and July 21, 2025; and

WHEREAS, this Council wishes to amend Ordinance No. 024-2025 for the purpose of reinstating the Regular Meeting originally scheduled for July 7, 2025.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cleveland Heights, Ohio, that:

SECTION 1. Ordinance No. 024-2025, Section 1, shall be amended to read as follows:

The regular Council meetings of ~~July 7, 2025 and July 21, 2025~~ are is cancelled and Council is recessed ~~during from~~ July 8, 2025 to July 31, 2025. Notwithstanding Section 111.02 of the Cleveland Heights Codified Ordinances, ~~during July 2025 while Council is in recess~~, a special meeting of Council may only be called by the President of Council or any two members of Council, upon at least 24-hour notice to members as provided in Section 111.02, with copy to the Mayor, or per a Resolution of Council passed at a ~~t~~ regular meeting. Any such notice must comply with Section 111.02.

SECTION 2. The July 7, 2025, Regular Meeting of Council is hereby reinstated and shall take place as if never cancelled.

SECTION 3. All other provisions of Ordinance No. 024-2025 not amended by this Ordinance shall remain in effect through this Ordinance and the prior version of Ordinance 024-2025 is hereby repealed in its entirety and replaced with this Ordinance.

SECTION 4. It is found and determined that all formal actions and deliberations of Council and its committees relating to the passage of this legislation that resulted in formal action were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised code.

SECTION 5. Notice of the passage of this Ordinance shall be given by publishing the title and abstract of its contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights, or by posting the full text to the City of Cleveland Heights website.

SECTION 6. It is necessary that this Ordinance become immediately effective as an emergency measure necessary for the preservation of the public peace, health, and safety of the inhabitants of the City of Cleveland Heights, such emergency being the need for efficient operation of the City and public awareness of Council's schedule of Regular Meetings. Wherefore, provided it receives the affirmative vote of five or more of the members elected or appointed to this Council, this Ordinance shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.
